### PHYSICAL AND CHEMICAL CHARACTERISTICS

**Appearance and Odor:** A long plastic, brown tube that can be separated for application. The pheromone formulation is within the dispenser and has an appearance of a colorless or light yellow transparent liquid with an oily-fatty, slightly waxy odor. The tube itself is odorless. Since the pheromone formulation is within the dispenser; the following characteristics are for the dispenser tube only:

**Melting Point:** 102-106°C

**Specific Gravity (Water = 1):** 0.92g/ml

**Boiling Point:** (solid)

**Evaporation Rate:** .035mg/dispenser/hr maximum

**pH:** 7 (the same as water)

**Net Contents:** Foil packets at 400 dispensers per packet. A packet is 12x8x3/4 inches. One dispenser contains 458.72 mg of pheromone. Total content of package: 183.49 gm.
